3. Destruction of high conservation values in forestry operations
4. Significant conversion of forests to plantations or non-forest use
5. Introduction of genetically modified organisms in forestry operations
6. Violation of national laws and regulations as they interpret the ILO Core Conventions as defined in the ILO Declaration on Fundamental Principles and Rights at Work

Futurewood Corp. is committed to practicing responsible fiber sourcing practices in North America to promote forestry practices that are both scientifically credible and economically, environmentally and socially responsible. In addition to the SFI, PEFC and FSC Standards, Futurewood Corp. recognizes and promotes certification to the American Tree Farm System® (ATFS®) Standard, the Canadian Standards Association (CSA®) and other internationally recognized certification standards.

Futurewood Corp. is committed to comply with applicable laws and regulations, including social laws such as those covering civil rights, equal employment opportunities, anti-discrimination and anti-harassment measures, worker’s compensation, indigenous peoples’ rights, workers’ and communities’ right to know, prevailing wages, workers right to organize, and occupational health and safety.
